

Striking the "R" word from Michigan Laws

New legislation just introduced into the House and Senate has advocates jumping for joy as a 15 bill legislative package would remove the words "mentally retarded" and "mental retardation" from all Michigan laws and replace them with People First language.

Peer Mentor and Advocate Ray Schuholz, who has attended numerous conferences across the country promoting "People First" language, is quite pleased. "This is a wonderful day for people with disabilities who have been fighting for the removal of these hurtful labels," said Peer Mentor and advocate Ray Schuholz. "We want society to look at our "ability" rather than our "disability". I am pleased that Michigan is moving forward in this very positive direction."

Michigan will now join all but six states who have removed the words from their law books.



Healthy Michigan Plan Coming Soon

Quality health care will soon be affordable and accessible to thousands of Michigan residents who are living below the federal poverty level and are not eligible for Medicaid. The Healthy Michigan Plan, which was approved by the Centers for Medicare and Medicaid Services, is being offered through the Michigan Department of Community Health. This health care program extends health care benefits to approximately 322,000 low income residents.

The eligibility for the program requires that you are:

- Between 19 to 64 years old
- Not currently eligible for Medicaid
- Not in or qualified for Medicare
- Not pregnant when applying for the Michigan Healthy Plan
- Have income up to 133% of the Federal Poverty level
- A Michigan resident

Budget Recommendations Released as Governor Snyder “Fuels Michigan’s Future”

In February, Governor Rick Snyder presented the state’s FY 2014-2105 Executive Budget recommendations. Some of the highlights include a plan to expand the Homestead Property Tax credit to provide \$103 million in tax relief for low and middle income taxpayers. This infusion of cash into the program is expected to impact 1.3 million Michigan residents. A few other recommendations related to behavioral health and developmental disability services include:

- \$72 million to implement the Healthy Michigan Plan (Medicaid expansion)
- \$15 million to support the just released Mental Health Commission’s recommendations
- \$122 million to the Michigan Health Savings Fund (used to offset future Medicaid expenditures)

ABLE Act Petition Gains Speed as Advocates are Confident the Bill Will be Passed in 2014

The momentum continues as the Achieving a Better Life Experience or ABLE Act gains votes in the House and Senate. Right now, a petition launched by National Down Syndrome Society Board member and Pennsylvania advocate Sara Wolff, has over 230,000 signatures. In order to be valid, the petition must have a total of 67,646 signatures. As of last count, the bill had 326 co-sponsors in the House and 62 in the Senate. Many advocates are confident this bill will be passed this year.

The ABLE Act will give people with disabilities access to savings accounts, allowing them choice and control, while protecting their Medicaid, SSI and other benefits. Savings accounts could be created accruing interest tax-free. The account could also fund a variety of essential expenses including medical and dental care, education, community based supports, employment training, assistive technology, housing and transportation.

Bill Introduced in Senate on Seclusion and Restraint Prevention

National legislation has been introduced that will provide federal protections for students by prohibiting abusive seclusion and restraint use in schools. The Keeping All Students Safe Act was introduced by Senators Tom Harkin (D-Iowa) and Chris Murphy (D-Conn) a few weeks ago.

The legislation was introduced after a report was released by the Government Accountability Office (GAO) indicating that parents were not notified that their children were restrained or secluded by the school and when they *did* find out, it was very difficult for them to put an end to the techniques implemented by the school. The GAO report reviewed 10 states.

Currently in Michigan as of January 2014, the Michigan School Discipline Task Force is revising the state’s Department of Education Model Code of Student Conduct. Task Force members will publish a report in April based on their findings. The group’s consensus so far is “to encourage school districts to reserve suspensions and expulsions only for those infractions required by law and to recommend proactive steps of positive behavior supports before articulating the school community’s consequences for disruptive behavior.” The revised version of the MDE Model Code of Student Conduct can be found at: <http://everyvoicecountsmi.org/>

Value of a Job Coach is Priceless

We all have our fears in life; spiders, heights or perhaps public speaking. Michael Pilotto, who has been working at Chuck E. Cheese in Canton for five years, had a fear of Chuck E. Cheese, the dancing mouse! But he has overcome that fear and improved in other areas of his job thanks to the efforts of his Job Coach.

“He used to hide when he saw the mouse costume come out while he was at work,” said Supports Coordinator Pam Bourdganis. “With the assistance of his Job Coach, he *now puts* on the costume and becomes Chuck E. Cheese! It’s part of his work responsibilities!”

About a year ago, Michael was getting distracted while on the job. “I believe there was a breakdown in communication between Michael and some of the employees,” said Beth Ann Pilotto, Michael’s mother. “We had a meeting with his Supports Coordinator and she suggested a Job Coach who worked closely with the restaurant manager to ensure Michael had what he needed to be successful on the job.”

Sarah Lentine, Chuck E. Cheese manager said she is pleased with the results. “Now that communication has improved, Michael understands what is expected of him and he goes above and beyond what we ask.” Job duties for Michael include maintaining the game room and eating area and performing as Chuck E. Cheese. He has been voted “Co-worker of the Year,” three out of the five years he has been employed!

Michael also volunteers at the Heartland Rehab Facility in Canton. “It’s so important to us and to him that he is out in the community, volunteering and meeting new people. He feels like he’s achieving something and giving back to the community and that’s what makes him happy.”
